The development of the ESSER III Safe Return to In Person Instruction and Budget Plan began in July 2021. To initiate the process, stakeholders were provided the opportunity to share their input to the Safe Return to In Person Instruction Plan. During this session, staff shared information on ESSER III and provided the space for stakeholders to share input on Covid-19 policies, procedures or other safety measures to be considered, considerations for students' academic, social-emotional/mental health and ideas for supporting high need students in the event of additional school closures. This plan was submitted to the California Department of Education on July 21, 2021.

As part of the budget plan process, ARUSD held input sessions to gather additional information from a variety of stakeholders. These input sessions were conducted virtually through Zoom in September 2021 and open to any member of the ARUSD community-teachers, support staff, members of the Management Team, parents, community members and students. All members of the various "underserved students" population were represented at the aforementioned input sessions. Stakeholders were invited to participate through informational flyers sent through Parent Square and District email and posted on the district website. All printed information and phone communication were provided in English, Spanish and Vietnamese.

In addition, leaders from the California School Employee Association (CSEA), Alum Rock Educators Association (AREA), and Teamsters were invited to provide input to the ESSER III budget plan. Each association President and other designated association representatives were invited to attend. Community partners were also invited to a meeting for district staff to hear their perspective on the type of support needed by our families.

In an effort to engage additional stakeholders, an on-line survey was created for students, parents and District staff. The ESSER III survey provided all District stakeholders the opportunity to share additional input. Parents were informed of the survey and provided the web link via Parent Square, messages on the District webpage and at school meetings . 2,384 stakeholders participated in the survey. Of these surveys, 764 were parents, 532 were staff members and 1,088 were students. 29.66% of respondents identified with a special population (Foster Youth, Unhoused students, Migrant Ed, English Learner, student with special needs under and IEP or 504 plan.

The following stakeholder input was taken into consideration during the development of the ESSER III Expenditure Plan. Items related to strategies for supporting student learning through implementation of evidence-based interventions as well as increased support for social emotional and mental health well being were developed in response to input from community members. Themes annotated with an "*" have related actions included within the ESSER III Expenditure Plan. Themes annotated with an "#" although not included within the ESSER III Expenditure Plan, are included in other district plans.

Findings from the Stakeholder Input Sessions include the following themes ranked in order of importance, as identified by the participants of input sessions:

- 2. Enrichment opportunities for students to connect socially #

- 4. Workshops/Trainings (Staff and Parents) #
- 5. VAPA/Sports enrichment opportunities for socialization and reintegration of students #

Using the prominent themes from the Stakeholder Input sessions, an ESSER III Stakeholder Survey was developed and targeted the following areas:

- 1. Prioritization for funding in the areas of Covid Safety, Supports for Learning Recovery, SEL/Mental Health Support, and Technology.
- 2. Prioritization for strategies to support Learning Recovery including Summer programming, Targeted Academic support during the school day, Technology/Connectivity, Academic Interventions, Additional instructional materials, On-line learning program, Before/after school tutoring, Additional professional development for staff, School year enrichment programs, Additional support for special student populations (ie. Foster Youth, unhoused students, English Learners, and students with special needs)
- 3. Prioritization for responding to social and emotional, mental health and other student needs including parent and staff development in area of SEL/Mental Health, increased counseling support, increased behavioral/emotional support.

The results highlighted the following priorities:

- 1. SEL/Mental Health Services 56.5%
- 2. Increased staff to support students within the school day 54.10%
- 3. Continued emphasis on student/staff safety 52.22%

In regards to supporting Learning Recovery, the following topics were the priorities:

- 1. Support for Special Populations -86.62%
- 2. Technology/Connectivity 84.69 %
- 3. Targeted Support/Interventions 80.42 %
- 4. Enrichment 79.31%
- 5. School Day Support 72.56%

In regards to Integrated Support for Students, the following topics were the priorities:

- 1. Additional Behavioral Support- 88%
- 2. Additional Counseling Support 83.56%
- 3. Staff development in SEL/Mental Health- 81.65%

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.
